In most cases, reasonable treatment and services under the Pilot will include consultation with the employee's General Practitioner, the cost of prescription medication and consultations with a psychologist and/or psychiatrist. The fee schedule for these services is provided below.

## GST

Maximum fees listed in this fee schedule are exclusive of GST. If GST is applicable, WorkSafe Victoria will pay the GST component in addition to the maximum fee.

The Pilot will pay the reasonable medical and like expenses for mental health injuries while an employee's claim is being assessed. For claims that are rejected, the Pilot will continue to cover reasonable medical and like expenses for the extended period.

There is no limit to the amount that can be paid to employees for their reasonable and like medical expenses during the provisional period.

#### What treatment and services are covered under the Pilot?

The Pilot will pay for medical and like expenses that are incurred by the employee.

In most cases, reasonable treatment and services will include consultation with the employee's General Practitioner, the cost of prescription medication and consultations with a psychologist and/or psychiatrist.

The employee's initial consultation with their General Practitioner (for the purpose of lodging their claim) will also be covered under the Pilot.

The Pilot will pay for psychology services by healthcare professionals who are fully registered with the psychology board of Australia.

The reasonable costs of hospital services in an in-patient or outpatient setting will also be covered. Employers should notify DJCS in circumstances where hospital services are claimed under the Pilot.

Other treatment and services, (including but not limited to aids and appliances, massage, exercise and swimming programs etc) may also be covered by the Pilot in circumstances where:



- (a) the employee's treating health practitioner provides a clinical justification in writing that the treatment or service is required.
- (b) The reasonable cost of travel expenses incurred by an employee to attend treatment and services will also be covered by the Pilot. Reasonable travel expenses will be paid in accordance with the WorkSafe policy and fee schedule where the Emergency Worker incurs the travel expense to attend any service listed below:
- (c) medical or allied health in room treatment and hospital treatment required as a result of a workrelated injury or illness, except for travel to or from a pharmacy.

Reasonable travel expenses are expenses for travel by:

- (a) private motor vehicle;
- (b) public transport; and
- (c) taxi or a ride share service driven by an accredited driver

Refer to policy and fee schedule for <u>travel expenses</u> for when the employer's approval is required before the expense is incurred, and for the amounts payable.

Occupational rehabilitation will be funded as part of the employee's WorkCover claim, however must be initiated prior to a claim being rejected. If a claim is rejected, any ongoing occupational rehabilitation is to cease at the expiry of the extended 13 week period.

#### What is the reasonable cost?

Under this Pilot, the reasonable costs of treatment and services should be determined using WorkSafe's schedule of fees.
